Preparation

DEEP FRY:

From frozen, place in a fryer basket, submerge in oil, and shake basket. Do NOT overpack product in basket. Cook the product for 3 - 4 minutes shaking the basket occasionally during cooking. For best performance hold product on a sheet pan, uncovered, with a wire rack, above 135°F in a dry heat environment.
