Ingredients

RED CHIPS: Ground Yellow Corn treated with Hydrated Lime, Water, Artificial Colors [Purified Water, Red 40, Yellow 6, Sodium Benzoate (Preservative), Phosphoric Acid (Acidity Regulator)], Liquid Preservative (Propionic Acid, Water, Sodium Hydroxide). YELLOW CHIPS: Ground Yellow Corn treated with Hydrated Lime, Water, Liquid Preservative (Propionic Acid, Water, Sodium Hydroxide). BLUE CHIPS: Ground Yellow Corn treated with Hydrated Lime, Water, Artificial Color [Purified Water, Red 40, Blue 1, Yellow 6, Yellow 5, Sodium Benzoate (preservative), and Phosphoric Acid (Acidity Regulator)], Liquid Preservative (Propionic Acid, Water, Sodium Hydroxide).

Preparation

THAW:
 Bring chips to room temperature before frying. Fill fry baskets half full. Fry the product until desired crispness or until the product stops bubbling, 30-45 seconds at 350° - 365° F. Gently agitate while frying. Remove baskets from fryer and shake off excess oil. Drain and empty contents into a bowl or onto a tray. Sprinkle on salt or desired seasoning blend over chips before oil dries completely.
